Sir,

I am writing to bring to your kind attention the decision taken by Honourable SG during the meeting on 18.03.2024 with representatives of the Surveyors Association (CHQ).

During this meeting, the Honourable Surveyor General of India reaffirmed the need for clear guidelines governing Surveyors' attachments to other offices/GDs of the Survey of India. It was mandated that no Surveyor should exceed a 3-month attachment period. Immediate implementation and the introduction of a rotation policy were promised to prevent undue family hardships to the employees . Furthermore, it was also assured that the replacement duration would be clearly specified in the movement orders during employee transitions.

Despite his clear assurance, a notable number of Surveyors from **Odisha & Chh. GD, Bhubaneswar** and **Kerala & Laksh. Wing, Thiruvananthapuram** are currently attached to Rajasthan GD, Jaipur, and Karnataka GD, Bengaluru respectively for periods surpassing 3 months.

Therefore Our Association requests the implementation of the decisions outlined during the meeting and relieves those surveyors who have already completed 3 months' time on attachment. Your prompt attention to this matter is eagerly awaited.
